Present - Valerie McCallum, Lisa Clinton, Nicole Collins, Kenny Kapa, Dale Hartsell

Agenda – A motion was offered by Collins, supported by Hartsell, to approve the agenda with the addition of the CAFPA equipment purchase. All in favor, motion carried.

May 15, 2025 Board of Trustee Regular Meeting Minutes — A motion was offered by Hartsell, supported by Collins, to approve the minutes as presented. All in favor, motion carried.

Supervisor – advised she is on the Thumb Region Materials Management Planning Committee.
